In pursuance of the advertisement issued for the recruitment of the posts of Junior T/Mate , Junior Helper(Sub-Station) and Junior Helper(Power House) (Electrical) (Class-IV post) by HPSEBL vide advertisement No.1/2018-dated 17-07-2018 and further addendum issued vide No HPSEBL (SECTT.) /2-12/2018-52400-01 dated 19-09-2018. On the recommendation of the Departmental Selection / Screening Committee constituted for making the appointments to the posts of the Junior T/Mates , Junior Helper(Sub-Station) and Junior Helper (Power House) (Electrical) (Class-IV posts), approval is hereby conveyed for the appointment of **130** Nos. candidates as **Junior Helper (Sub-Station)** (Class-IV post), falling in the share of various categories in accordance with model roster notified by the Govt. of H.P. and further adopted by the HPSEBL against the sanctioned posts of Junior Helper(Sub-Station) in Electrical Divisions under Operation and Electrical System Wings , with their place of posting shown against each as per the terms and conditions mentioned below, purely on **contract basis** in the Pay Band of Rs. -4900-10680+1300 grade pay +an amount equal to 100 % of grade pay as per R&P Rules.
