OFFICE ORDER

Subject: - Grant of Dearness Allowance to the employee of the Himachal Pradesh State Electricity Board Limited w.e.f 01.07.2017.

In continuation to this office order endorsement No. HPSEBL (SECTT)/R&E/14-71/2017-52271-52550 dated 26.09.17, the Himachal Pradesh State Electricity Board Ltd., is placed to enhance Dearness Allowance @ 3% from the existing rate of 134% to 137% w.e.f.01.07.2017 in respect of employees of the HPSEB Ltd. and @ 1% from existing rate of 4% to 5% in respect of the Officers of All India Services who are drawing pay in the revised pay scales.


1. The Additional rate of Dearness Allowance of 3% & 1% shall be paid in cash with the salary of January, 2018 payable in February, 2018 and the arrear accrued w.e.f. 1.07.2017 to 31.12.2017 shall be credited in the General Provident Fund Account of the employees with salary of January, 2018. The interest on this account shall accrue w.e.f. 1st February, 2018.

2. In the case of HPSEB Ltd., employee who have retired in between or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional installment of DA w.e.f. 01.07.2017 will be paid in cash with the salary of January, 2018 payable in February, 2018.

3. These orders will be applicable to regular employees covered by H.P. State Electricity Board Ltd., (Revised Pay) Regulations, 2009 and work charged employees working in HPSEB Ltd.

4. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.


