The Himachal Pradesh State Electricity Board Limited is pleased to make the following Regulations further to amend the HPSEB Limited (Revised Pay) Regulation-2009 namely:-

1. Short title and commencement:-

- 1) These Regulations shall be called the Himachal Pradesh State Electricity Board Limited (Revised Pay), Regulations,-2009 (Second Amendment-2010).
- 2) They shall be deemed to have come into force on and with effect from the First day of January, 2006.

2. In the HPSEB Limited (Revised Pay) Regulations, 2009 (hereinafter referred to as the said Regulations), in Regulation-5 the second proviso shall be substituted namely:-

 "Provided further that the Board employees may elect to switch over to the revised pay structure from the date of any promotion, up-gradation of Pay Scales under Assured Career Progression Scheme, Time Bound Promotional/Devised Promotional Scales, or otherwise, earned in between 01-01-2006 & the date of Notification of HPSEB Limited (Revised Pay), Regulations, 2009 i.e. 30.12.2009."


Explanation-1 under Regulation-5 shall be omitted.

3. Due to this amendment, the employees may exercise revised option up-to 30.09.2010.(The employees who have already exercised their option before the issue of this amendment may also be given a chance to exercise their revised option).


