

The conversion on workcharge cadre of above workmen will be from prospective effect i.e. from the date of issue of appointment order/joining. These posts have been revived on temporary basis and will be personal to the incumbent. These posts will be abolished on promotion/ retirement/ death and termination of the incumbent from the service.


However, the upper age limit and educational qualification for Class-IV Tech./Non-Tech. is relaxed as per the instruction issued vide letter No.HPSEB (Sectt)/ R&E/ 106/ 11/ 2010-30948-31148 dated 5.6.10. In case of daily waged workers whose cases are pending in different adjudicatories, their services shall be brought on regular basis subject to the final outcome of the Court decision.

You are therefore, directed to issue necessary order on workcharge cadre after completion of all codal formalities in respect of above mentioned daily waged worker. Their pay will be regulated as per the instructions/notifications issued by HPSEBL from time to time.
