



OFFICE ORDER

Subject: Grant of Dearness Relief to Himachal Pradesh State Electricity Board Ltd. Pensioners/Family Pensioners- Revised rate effective from 1.7.2010.

In continuation to the office order No. HPSEB(SECTT)/R&E/6-156/2010-81908-82158 dated 27.9.2010, the Himachal Pradesh State Electricity Board Ltd. is pleased to decide that dearness relief payable to the Board's Pensioners/Family Pensioners shall be enhanced from the existing rate of 35% to 45% w.e.f. 1.7.2010 on the following terms and conditions:-

1. The Dearness Relief may be released after adjusting the extra amount, if any, paid to pensioners in cases where the total unrevised pension exceeded revised pension, if still unadjusted, as brought out in para 8 of Principal Secretary (Finance) to the Government of Himachal Pradesh Office Memorandum No. Fin(Pen)B(10)-6/98-III dated 14.10.2009 made applicable in H.P. State Electricity Board vide Notification No. HPSEB (SECTT)/6-156/2009-169106-305 dated 23.1.2010.
2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
3. Other provisions governing grant of Dearness Relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
4. These orders shall apply to all the Pensioners/Family Pensioners of the HPSEB Ltd.
5. As dearness relief will now be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith dearness relief orders. It will be the responsibility of the pension disbursing authority, including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.
6. The Chief Accounts Officer, Drawing Disbursing Officer & the authorized Public Sector Banks are requested to arrange payment of Dearness Relief to pensioners on the basis of these orders.
7. The Dearness Relief on pension & family pension @ 45% will be paid with the pension/family pension for the month of April, 2011 payable in May, 2011. The arrears accrued on account of dearness relief w.e.f. 1.7.2010 to 31.3.2011 shall be paid in cash in one instalment in the month of April, 2011.
