### \*OFFICE ORDER\*

**Subject: -** Grant of Dearness Relief to Himachal Pradesh Government Pensioners/Family Pensioners-Revised rate effective from 01.01.2018.


In continuation to this office order endorsement No. HPSEBL (SECTT) R&E/14-71/ 2017-76945-77225 dated 22.1.2018, the Himachal Pradesh State Electricity Board Ltd. is pleased to decide that dearness relief payable to the HPSEBL Pensioners/Family Pensioners shall be enhanced from existing rate of 137% to 140% w.e.f. 01.01.2018, the HPSEBL is further please to decide that dearness relief payable to pensioners/family pensioners of All India Services of Himachal Pradesh Cadre who are drawing their revised pension on the basis of 7<sup>th</sup> Central Pay Commission report shall be enhanced from present rate of 5% to 7% w.e.f. 01.01.2018.

1. Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
2. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc, will remain unchanged.
3. These orders shall apply to all the Pensioner/Family Pensioner of the HPSEB Ltd.
4. As dearness relief will now be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the Pension Disbursing Authority (PDA), including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.

5. The Additional Dearness Relief @3% and @2% respectively (enhanced from 137% to 140% and 5% to 7%) shall be paid with the pension/family pension for the month of November, 2018 payable in the month of December, 2018. The arrears accrued on account of dearness relief w.e.f. 01.01.2018 to 31.10.2018 may be paid in one installment, along with pension/family pension for the month of November, 2018, payable in month of December, 2018.


