



Himachal Pradesh State Electricity Board Ltd. is pleased to grant of Interim Relief @4% of basic pension/basic Family Pension w.e.f. 01.07.2018 to its pensioners/ family pensioners on the following terms and conditions:-

1. No Dearness Allowances would be payable on this Interim Relief.
2. These orders shall apply to HPSEB Ltd. Pensioners/Family Pensioners (excluding)/ (Pensioners of All India Services).
3. The Interim Relief on pension and family pension @ 4% will be paid with the pension /family pension for the month of August, 2018 payable in the month of September, 2018. The arrears accrued on account of grant of Interim Relief w.e.f. 01.07.2018 to 31.07.2018 shall be paid in cash in one instalment with the pension /family pension for the month of August, 2018 payable in the month of September, 2018.
4. Payment of Interim Relief involving a fraction of a Rupee Shall be rounded off to the next higher Rupee.
5. This Interim Relief will be absorbed in future pension /family pension revision to be allowed by the HPSEB, Ltd.
