Subject: Settlement of pension cases strictly as per the provision/ procedure prescribed in CCS Pension Rules 1972.

Sir,

I am directed to invite your attention towards this office letter No. HPSEB/F&A// Pen/ Misc./2011-32728-893 dated 11.8.2011 vide which the detailed instructions have been issued with regard to settlement of pension cases of retiring employees within scheduled time of the provision/ procedure prescribed in the CCS Pension Rules 1972. But the instructions issued by this office do not seem to have been taken seriously and the cases are still being delayed abnormally one pretext or the other.

In this connection, attention is once again invited towards Sub-Rule-4 of Rule 68 of CCS (Pension) Rule 1972 and GOI's decision No.5 below this rule which envisages the provision to fix responsibility at all levels to recover the amount of interest so paid from the concerned dealing official, supervisor and Head of Office in proportion to their salary.

It is also relevant to mention here that due to delay in finalizing the Pension/Family Pension cases, lot of Court cases are arising therefrom and in one such case, the Hon'ble High Court of HP has also desired to fix the responsibility of erring Officer/ official and to recover the amount of interest from them wholly or in proportion.

In view of the above, it is once again emphasized upon all concerned that the procedure/ time frame as prescribed in Chapter-VIII i.e. Rule 56 to Rule 74 of CCS (Pension) Rule 1972 may be followed strictly failing which the amount of interest payable in such cases will be recovered from the Officer/ Official responsible for such delay as per provision contained in aforementioned rules/ procedure.

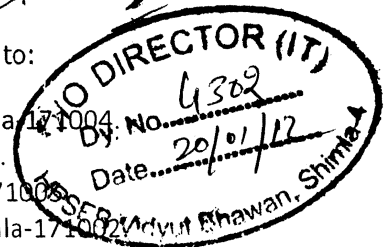
