'ORDER'

Sh. Kamlesh Bhardwaj, Supdt. Gr.-II was working in Elect. Division, HPSEB Ltd., Anni and transferred to Elect. Division, HPSEB Ltd., Theog vide office order No. 63 dated 5.5.2017 and joined as such on 6.5.2017. Later on the transfer and posting orders of Sh. Kamlesh Kumar, Supdt. Gr-II has been withdrawn vide this office order No. 68 dated 6.5.2017 and Sh. Surinder Kumar, Supdt. Gr-II has been transferred from the O/O Chief Engineer (SP) HPSEB Ltd., Shimla to Elect. Division, HPSEB Ltd., Theog vide office order No. 69 dated 6.5.2017 and joined as such on 8.5.2017.

AND WHEREAS, after withdrawing his transfer order from Elect. Division, Anni to Elect. Division Theog he has filed an OA No. 1978 of 2017 titled as Sh. Kamlesh Bhardwaj Supdt. Gr-II Vs HPSEB Ltd.,. The O.A. aforesaid came up for hearing before the Hon'ble Administrative Tribunal on 11.5.2017 when the following orders/judgement came to be passed:

In the facts and circumstances of the case, the original application is disposed of with a direction that the applicant may file a comprehensive representation along with a certified copy of this order for cancellation of his transfer or suitable adjustment to 5th respondent within three days, 5th respondent shall decide the same after affording an opportunity of being heard to the applicants if so desired by 18th May 2017.


AND WHEREAS, in pursuance of orders dated 11.5.2017 passed by Hon'ble Administrative Tribunal the Applicant was given personal hearing on dated 25.5.2017 vide letter dated 20.5.2017.

AND WHEREAS, Sh. Kamlesh Bhardwaj, Supdt. Gr-II has since submitted his representation on 15.5.2017 in pursuance of the aforesaid order passed by the Hon'ble Administrative Tribunal of H.P. whereby he has requested that after looking in to the above true facts the applicant be allowed to be posted at Theog and his withdrawal be ordered to be set aside and the order dated 5.5.2017 AnnexureA-I be uphold for all intents and purposes.

AND WHEREAS, at present a post of Supdt. Gr-II is sanctioned for Elect. Division, HPSEB Ltd., Theog against which only one Supdt. Gr-II can be posted there. However, the previous postings of Sh. Kamlesh Bhardwaj, Supdt. Gr-II (DOB-23.6.1971) are as under:-

1. Shimla 3.12.91 to 13.3.2008
2. Theog 14.3.2008 to 31.1.2016
3. Anni 3.2.2016 to date.

NOW THEREFORE, taking into consideration the facts and circumstances of the case sympathetically and in pursuance of the orders/judgment dated 11.5.2017 Sh. Kamlesh Bhardwaj, Supdt. Gr-II who is transferred from Elect. Division, Anni to Elect. Division, HPSEB Ltd., Theog vide office order No. 63 dated 5.5.2017 is hereby directed to join in Elect. Division, Anni with immediate effect.
