The inter-se-seniority of the above named officials in the grade of Foreman (Line) shall be fixed later on.

The controlling officers shall verify the name, exact date of birth and Academic Technical qualification eligibility criteria as required under the Rule be verified before allowing the promotee (s) to join as Foreman (Line). They will also ensure that no vigilance case is pending or being contemplated against them and no court case has been filed in the court in any manner, before relieving the promotee (s) or allowing them to join as Foreman (Line), if so the matter be reported to this office and the official may not be relieved.

The officials on their promotion as Foreman (Line) should exercise the option with regard to date of increment/pay fixation under the provision of Revised Pay Regulation 2009, 11(iv) within a period of one month after assuming the charge of the post.




