
The inter-se Seniority of the above named officials in the grade of Mechanic/ Electrician (Auto) will be fixed later on.

All the above officials shall join their new assignments within 15 days positively from the date of issue of the orders, failing which, the promotion orders shall be deemed as cancelled without any further notice and no extension in joining time will be granted.

The controlling officers shall ensure that these officials are relieved immediately to enable them to join new places of posting on promotion. Their relieving should not be delayed on any pretext unless the official(s) voluntarily foregoes/forego the promotion and give(s) the request to this effect, in writing, which may be forwarded to this office without any delay.

- (iii) All the concerned controlling offices are advised that the photocopy of joining report of each incumbent may be sent to this office immediately.




