WHEREAS the Applicant Sh. Vinod Kumar, Supdt.(D/A) was working in Electrical System Division, HPSEB Ltd., Bilaspur and transferred to Electrical Division, HPSEB Ltd, Reckong Peo in place of Sh. Mohammad Shahid, Supdt.(D/A) on vice versa basis vide this office order No.573 dated 20.11.2015 endst. No.HPSEBL (SECTT)/NGE/6-77/2015-66393-403 dated 20.11.2015.

AND WHEREAS Sh. Vinod Kumar, Supdt.(D/A) aggrieved with his aforesaid transfer preferred O.A.No.4583 of 2015 titled Vinod Kumar V/S HPSEB Ltd., and others in the Hon'ble Administrative Tribunal at Shimla. The O.A aforesaid came up for hearing before the Hon'ble Administrative Tribunal on 06.09.2016 when the following orders/directions came to be passed:-

"with the consent of the parties, the original application is taken up for disposal at this stage.

The applicant is Superintendent Electrical System Division, HPSEB Ltd., Bilaspur from September, 2011 vide Annexure-A-I, he is transferred to Electrical Division, HPSEB Ltd., Reckong Peo. His transfer, per him, has been effected on D.O. note to accommodate respondent No.3. He seeks cancellation of his transfer or suitable adjustment.

In the facts and circumstances of the case and interest of justice, the original application is disposed of with a direction that he may file a comprehensive representation, supported by documents, before 1st respondent through Executive Director to HPSEB Ltd., within a week from the receipt of a certified copy of this order. 1st respondent shall consider and decide the same in accordance with law and transfer policy, within two weeks, after affording an opportunity of being heard to the applicant and respondent No.3, if so desired. The applicant shall produce a certified copy of this order before 1st respondent within a week.

Till decision of the representation, status quo as on today be maintained.

The pending Misc. application(s), if any also stands disposed of."

AND WHEREAS in pursuance of aforesaid orders the Applicant Sh. Vinod Kumar, Supdt.(D/A) has not been relieved till to date.


AND WHEREAS in pursuance of orders dated 06.09.2016 passed by the Hon'ble Administrative Tribunal the Applicant and Respondent No.3 were given personal hearing on dated 05.11.2016 vide letter dated 17.10.2016.

Accordingly, the Applicant and Respondent No.3 have attended the same on dated 05.11.2016 and Applicant Sh. Vinod Kumar, Supdt.(D/A) has submitted his representation and requested that he may be transferred/adjusted in Electrical Division, HPSEB Ltd., Thalout against vacancy.

AND WHEREAS the Respondent No.3 Sh. Mohammad Shahid, Supdt.(D/A) who has temporarily deputed in Electrical Division, HPSEB Ltd., Bilaspur, he can be transferred to Electrical System Division, HPSEB Ltd., Bilaspur and Sh. Raj Kumar, Supdt.(D/A) who was under order of transfer from the office of the Chief Engineer(Comm.), HPSEBLtd., Shimla to Electrical Division, HPSEB Ltd., Bilaspur vide office order dated 01.12.2015 and lateron temporarily adjusted in the office of the Chief Engineer (Comm.), HPSEB Ltd., Shimla can be transferred to Electrical Division, HPSEB Ltd., Bilaspur.

NOW THEREFORE taking into consideration the facts and circumstances of the case and in pursuance of the order/judgement passed by the Hon'ble H.P. Administrative Tribunal, the following transfer/adjustments and postings of Supdt.(D/As) are hereby ordered with immediate effect:-
